### WHAT IS RESTORATIVE JUSTICE?

Restorative Justice (RJ) is an approach to **justice** in which the response to a crime is to organize a conference between the victim and the offender, and sometimes with representatives of a wider community as well. The goal is to negotiate for a resolution to the satisfaction of all participants involved.

### HOW DO I QUALIFY?

- Are you Inuk?
- Are you an adult (18 or over)?
- Have you pled or been found guilty of a crime?
- If yes, then Gladue is for you!

### HOW DOES THIS BENEFIT ME?

- It offers the police and judges an opportunity to deal with the wrong-doing outside of the criminal justice system.
- Giving you, the victim and community more control over restoring harmony and the possible healing outcomes.
- You have access to culturally specific healing programs to suit your needs.
- Once you have successfully completed the program and prove that you have made amends, the police or judge may decide to drop the charges.

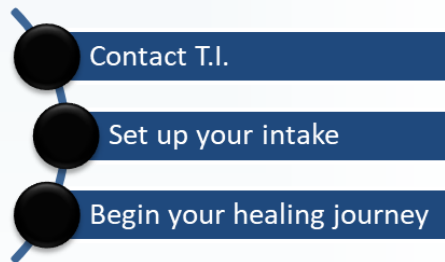
### DOES IT COST MONEY?

### THE RESTORATIVE JUSTICE COMMITTEE

The goal is for the RJ Liaison and the Justice Committee to work with Ottawa Urban Inuit, to provide an opportunity for offenders to do right by those they have hurt. TI provides access to culturally appropriate and culturally relevant programming and services by following the **8 Inuit Qaujimagatuqangit (IQ) guiding principles**.



### WHAT DO I NEED TO DO

- Meet or call the Restorative Justice Liaison (contact info on back) to discuss entering the program and next steps.
- You will be assigned to a facilitator from the RJ Committee, they will work with you and the other parties to prepare you for the conferencing.
- A date will be set to bring everyone together. Conferencing will take place. It will give you and the other parties a space to express how the offence has affected everyone and how to move forward.
- Recommendations for your healing will be made, written and signed by everyone and reported to the courts.
- Continue to meet with the Restorative Justice Liaison for aftercare programming.
